



DRAINAGE EASEMENT WITHIN SECTION 24, TOWN 10 NORTH, RANGE 16 WEST MUSKEGON, MI

KNOW ALL MEN BY THESE PRESENTS, THAT McDONALD'S CORPORATION, a Delaware corporation, hereinafter referred to as Grantor, for and in consideration of One Dollar (\$1.00) in hand paid by the Muskegon County Drain Commission, the receipt of which is hereby acknowledged, hereby grant, bargain, sell and convey unto the Muskegon County Drain Commission a permanent and perpetual easement for storm drainage purposes over, under and across the following property situated in the southeast quarter of Section 24, Town 10 North, Range 16 West, City of Muskegon, Muskegon County, Michigan, to wit:

A twenty foot (20') wide strip of property located along the west and north boundaries of the following described property:

Part of the south 1/2, of the east 1/2, of the southeast 1/4, of the southwest 1/4, of section 24, town 10 north, range 16 west, township of Muskegon, County of Muskegon, State of Michigan, described as follows:

<u>COMMENCING</u> at the south quarter corner of said section 24; Thence north 00 degrees 38 minutes 53 seconds east, along the north-south quarter line, a distance of 90.00 feet;

Thence south 89 degrees 29 minutes 18 seconds west, parallel with the south line of said section 24, a distance of 403.03 feet to the <u>POINT OF BEGINNING</u>;

Thence continuing south 89 degrees 29 minutes 18 seconds west, along said line, a distance of 258.97 feet to the west line of the east 1/2, of the southeast 1/4, of the southwest 1/4; Thence north 00 degrees 28 minutes 15 seconds east, along said line, a distance of 569.41 feet to the north line of the south 1/2, of the east 1/2, of the southeast 1/4, of the southwest 1/4; Thence north 89 degrees 18 minutes 28 seconds east, along said line, a distance of 260.75 feet; Thence south 00 degrees 38 minutes 53 seconds west, parallel with the north-south quarter line, a distance of 570.28 feet to the POINT OF BEGINNING.

Said parcel contains 3.40 acres, more or less.
