FINAL ORDER OF DETERMINATION OF LEVEL OF GRAND LAKE

The Petition filed in the above cause on behalf of the Board of Supervisors of Presque Isle County, Michigan, praying for the determination of a legal normal level of Grand Lake, Presque Isle County, pursuant to Act No. 194, P. A. 1939, as amended, having come on to be heard, after due notice of hearing and publication as required by said statute; Elmer L. Radka, Prosecuting Attorney, representing the petitioner; Frank G. Millard, Attorney General, by Florence Clement Booth, Assistant Attorney General, appearing as counsel for the Department of Conservation of the State of Michigan; and various riparian owners of land located on said Grand Lake appearing by their counsel in accordance with written appearances heretofore filed in this cause; the following counsel being present at said hearing: Frederick F. Hempel, William Knapp, Donald E. Gillard, George M. Holmes; and the court having heard the testimony, examined the evidence and being fully advised in the premises:

IT IS HEREBY ORDERED that the normal height and level of the waters of Grand Lake located in Sections 22, 23, 24, 25, 26, 27, 28, 29, 35 and 36 of Krakov Township, Town 34 North, Range 7 East, Presque Isle County, Michigan, and in Sections 19, 29, 30, 31, 32 and 33, Presque Isle Township, Town 34 North, Range 8 East, Presque Isle County, Michigan, and in Sections

4, 5, 6, 8, 9, 10, 14, 15, 16, and 17, Presque Isle Township, Town 33 North, Range 8 East, Presque Isle County, Michigan, be and the same is hereby fixed and determined to be 594.00 feet above mean sea level datum.
