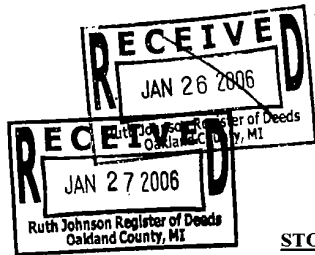

STORM SEWER EASEMENT AGREEMENT

This Storm Sewer Easement Agreement ("Easement") is made this December 19, 2005 by and between Haggerty Medical Center Building, L.L.C., a Michigan limited liability company, of 5042 Crestmont, Troy, MI 48098 ("HMCB") and Arthur Cervi and Suzanne Cervi, husband and wife, of 28331 Haggerty Road, Novi, Michigan 48377 ("Cervi").

BACKGROUND

- A. HMCB owns the real property described on the attached Exhibit A ("HMCB Property").
- B. Cervi owns the real property described on the attached Exhibit B ("Cervi Property").
- C. HMCB is developing its property and intends to construct a storm water drainage system on HMCB's Property and partly on Cervi's Property ("Storm Water Drainage System"). The Storm Water Drainage System will drain into an existing wetland on Cervi's Property.
- D. HMCB has requested, and Cervi is willing to grant, an easement over a portion of Cervi's Property for the purpose of constructing and operating the Storm Water Drainage System. In addition, Cervi will have the right to tap into and utilize the Storm Water Drainage System as set forth herein.
- E. The parties desire to set forth the easements to be granted, the rights to be reserved, the terms and conditions of such easements, all in accordance with the terms and conditions of this Easement.

One (\$1.00) Dollar,
NOW THEREFORE, in consideration of the mutual covenants contained herein and no other good and valuable consideration, the receipt, adequacy and sufficiency of which is hereby acknowledged, the following grants, agreements and covenants are made:

EASEMENT

1. Cervi does hereby grant and declare to HMCB, its successors and assigns, for the benefit of HMCB's Property, and the owners, lessees, mortgagees and occupants thereof, a non-exclusive perpetual easement on, over, across and under that portion of Cervi's Property as described in the attached Exhibit C (the "Cervi Easement") for the purpose for storm water and surface water drainage, which shall include the construction and operation of underground

drainage pipes, channels and other drainage facilities. The Cervi Easement shall also include the right to discharge storm water and surface water into the existing wetland on Cervi's Property, as depicted and described on the attached Exhibit D, and the right to maintain, repair and replace the drainage facilities. Cervi shall be prohibited from altering or placing anything in the Cervi Easement which shall obstruct or impede the flow of storm water or surface drainage, and Cervi agrees not to build, or to convey to others, permission to build any structures or improvements on, over, across, or under the Cervi Easement or the wetland, or develop or allow the development of the Cervi Easement or the wetland, in any manner which would or could obstruct the free flow of storm water drainage.

HMCB will construct the Storm Water Drainage System in accordance with the plans and specifications prepared by HMCB and will pay for all labor and material associated with its construction and installation thereof. To the extent that any property, pavement, curb, landscaping or vegetation is disturbed by the construction and installation of the Storm Water Drainage System, HMCB shall be responsible to restore the area to a condition that existed as reasonably possible prior to such event.

2. Cervi hereby grants to HMCB a temporary construction easement of a reasonable width adjacent to the Cervi Easement for purposes of constructing the Storm Water Drainage System. Following such construction, HMCB shall restore the temporary easement area to condition that existed as reasonably possible prior to such event.

3. HMCB does hereby grant and declare to Cervi, its successors and assigns, for the benefit of Cervi's Property, and the owners, lessees, mortgagees and occupants thereof, a non-exclusive perpetual easement on, over, across and under that portion of HMCB's Property as described in the attached Exhibit E (the "HMCB Easement") for the purpose of tapping into and connecting to the Storm Water Drainage System, at Cervi's cost and expense, which shall include the right to construct and operate underground drainage pipes, channels and other drainage facilities within the HMCB Easement area and the right to discharge storm water and surface water into the Storm Water Drainage System.

If Cervi taps into or connects to the Storm Water Drainage System as provided herein, then Cervi shall pay for all labor and material associated with its construction activities and shall cause its work to be done as expeditiously as possible and in a manner that minimizes interference with the use and occupancy of HMCB's Property by its owners, guests and invitees. To the extent that any property, pavement, curb, landscaping or vegetation is disturbed by Cervi's connection to the Storm Water Drainage System, Cervi shall be responsible to restore the area to a condition that existed as reasonably possible prior to such event.

4. The need for any maintenance or repair of the Storm Water Drainage System shall be determined by HMCB and HMCB initially shall be responsible for paying the maintenance and repair costs. Once Cervi's Property is developed and connects to the Storm Water Drainage System, then the owner of Cervi's Property shall reimburse HMCB for a pro-rata share of the maintenance and repair costs within thirty (30) days after receipt of written notice from HMCB. Unless the parties mutually agreed upon another cost sharing arrangement, then the pro-rata share shall be determined by utilizing a formula that uses a percentage, the numerator of which is the total acreage of Cervi's Property, and the denominator of which is the combined acreage of

HMCB's Property and Cervi's Property. In the event the owner of Cervi's Property shall fail to pay its pro rata share, then HMCB shall have the right to file a lien against Cervi's Property and undertake any collection method allowed by law. Notwithstanding the above, any maintenance costs arising out of damage to the Storm Water Drainage System caused by the negligent or intentional acts or omissions of HMCB or Cervi, or their guests, invitees, successor or assigns, shall be the sole responsibility of such property owner.

5. If any provision of this Easement is held by a court of competent jurisdiction to be invalid, void or unenforceable in any manner, the remaining provisions of the Easement shall nonetheless continue in full force and effect without being impaired or invalidated in any way. In addition, if any provision of this Easement may be modified by a court of competent jurisdiction such that it may be enforced, then such provision shall be so modified and as modified shall be fully enforced.

6. This Easement and all of its terms and conditions shall be a covenant running with the land binding upon and inuring to the benefit of HMCB's Property and Cervi's Property, and their respective owners, successors, assigns, occupants, tenants, employees, agents, invitees, mortgagees and customers.

7. This Easement may be amended, modified or terminated (in whole or in part) only by the agreement of the then current owners of HMCB's Property and Cervi's Property, their successors and assigns, in writing, and duly recorded in the office of the Register of Deeds of Oakland County, Michigan.

8. If a property owner hereto defaults in its obligations pursuant to this Easement, then the non-defaulting party(ies) shall have the right, in addition to all rights and remedies provided hereunder or available under applicable law, to enforce the provisions of this Easement by an appropriate action at law or in equity, including, without limitation, an action for specific performance.


9. All notices, demands and requests given or required to be given pursuant to this Easement shall be in writing. All such notices, demands and requests shall be deemed to have been properly given if served in person, by messenger or courier service, by express overnight delivery, or by United States registered or certified mail, postage prepaid, return receipt required, addressed to the address of the respective properties hereunder. Any notice given in accordance with the provisions of this paragraph shall be deemed to be received and effective on the date of delivery if personally delivered, two days after the date mailed, if mailed, or one day after the date delivered to an express courier if sent by express delivery.


10. This Easement shall be governed by the laws of the State of Michigan.


